Mayor Johnson Called the Rock Creek City Council meeting to order at 7PM with the pledge of allegiance.

Consent Agenda: Don Ramberg motioned seconded by Dan Saumer to approve the consent agenda with the following additions; Review SSTS ordinance 6. a. iii, Discuss Policy & procedures 6.c.i, Discuss Fire Substation 7.c. Motion carried all ayes.

Dan Saumer motioned seconded by Don Ramberg approval of February 6, 2025 meeting minutes. Motion carried all ayes.

Don Ramberg motioned seconded by Sam Christenson approval of the March Disbursements. Motion carried all ayes.

Department Reports:

Planning Commission: Don Ramberg motioned seconded by Dan Saumer approval of Amended Ordinance 2004-43 Standard Road Specs. Motion carried all ayes.

After further discussion Sam Christenson amended the motion seconded by Nancy Rys to the 3rd Tuesday of the month starting May 20, 2025. Motion carried all ayes.

Old Business: Sam Christenson motioned seconded by Don Ramberg to appoint council member Dan Saumer to the Safety Committee. Motion carried all ayes.

Dan Saumer motioned seconded by Don Ramberg to appoint council member Nancy Rys to the Safety Committee. Motion carried all ayes.

Don Ramberg motioned seconded by Sam Christenson to appoint Curt Kubesh, public works to the safety committee. Motion carried all ayes.

Council members agreed to have Bob Carlson as an advisory member of the safety committee.

Appointment of 4 residents from the community: Sheri Skluzacek, Tom Lindstrom, Chelsy Lindman and Curtis Christian.

Starting May 12th 2025, the Safety Committee will meet on the 2nd Monday of the Month at 5pm. The first order of business will be talking about the creation of a Fire Substation in the City of Rock Creek.
