

Rock Creek City Council
Summary Minutes
September 5, 2024

The Rock Creek City Council meeting was called to order at 7PM by Mayor Johnson.

Members: Ronnie Berdan, Dan Saumer, Sam Christenson, Don Ramberg and Dick Johnson.

Others present: Deputy Clerk Ashley Rauschnot, Public Works Curt Kubesh, City Sewer Inspector Amy Thompson, and interested citizens.

Ronnie Berdan motioned seconded by Don Ramberg approval of the August 9, 2024 minutes. Motion carried all ayes.

Don Ramberg motioned seconded by Ronnie Berdan approval of the August 15, 2024 Special Meeting minutes. Motion carried all ayes with Sam Christenson Abstaining.

Dan Saumer motioned seconded by Ronnie Berdan to set the Truth-in-Taxation (TNT) date for Monday, November 25, 2024 at 7PM. Motion carried all ayes.

Dan Saumer motioned seconded by Sam Christenson to approve the fee schedule as is. Motion carried all ayes.

Ronnie Berdan motioned seconded by Don Ramberg approval of the Resolution for the 2024 Proposed Tax Levy Collectible in 2025; General Fund \$210,000.00. Motion carried all ayes.

Don Ramberg motioned seconded by Ronnie Berdan approval of the Proposed Budget Summary. Motion carried all ayes.

Dan Saumer motioned seconded by Ronnie Berdan to hold a public hearing on October 3, 2024 to extend Ordinance #74. An Ordinance providing a moratorium on the sale of hemp derived THC (Tetrahydrocannabinols) food and beverages in the City of Rock Creek. The extension is needed in order to complete the study as allowed by State law. Motion carried all ayes.

Dan Saumer motioned seconded by Don Ramberg to defer the allocated state funds for elections, in the amount of \$462.02 to Pine County to help offset county election expenses in 2024. Motion carried all ayes.

Don Ramberg motioned seconded by Ronnie Berdan to appoint election judges for the General Election November 5, 2024; wage set at \$20.00 an hour. Motion carried all ayes.

Dan Saumer motioned seconded by Don Ramberg approval of Resolution approving the vacation and rescission of a portion of the Plat of Ostrands St, Croix Vista. The Vacated Property, Lots 2-4 Block 3 will be combined with parcel 43.0115.001 which is owned by the Petitioner and currently zoned Rec-1. Motion carried all ayes, Sam Christenson abstained.

Don Ramberg motioned seconded by Sam Christenson to approve payment of check #'s 17293 - 17345 and e-transfers totaling \$41,819.80. Motion passed all in favor.

Dan Saumer moved seconded by Don Ramberg to adjourn the Council meeting at 8:33PM. Motion carried with all ayes.
