

**SUMMARY MINUTES OF THE  
CITY OF ROCK CREEK  
December 1, 2022**

The Rock Creek City Council meeting was called to order at 7:02PM by Mayor Johnson.

Members present: Ronnie Berdan, Dick Johnson, Dan Saumer Sam Christenson and Don Ramberg.

Ramberg moved seconded by Saumer to approve the November 3, 2022 Council minutes. Motion carried all ayes.

Ramberg moved seconded by Saumer to approve the November 15, 2022 Canvas Board minutes. Motion carried all ayes.

Ramberg moved seconded by Saumer to approve the November 28, 2022 TNT minutes. Motion carried all ayes.

Saumer moved seconded by Berdan to approve the Resolution adopting the 2022 proposed tax levy collectible in 2023, upon taxable property in the City of Rock Creek, for the following purposes.

Fire	<u>\$40,000</u>
Total	\$210,000

Motion carried all ayes.

Berdan moved seconded by Christenson to adopt the Final Budget for 2023 as proposed. Motion carried all ayes.

Ramberg motioned seconded by Christenson to approve the amendments to the SSTS Ordinance per the local government unit assessment by the MPCA. Motion carried all ayes.

Ramberg moved seconded by Christenson to adopt the Resolution to make the City of Rock Creek's Elected Officials "Employees" for work comp. Motion passed all ayes.

Berdan moved seconded by Saumer to approve the City Council Payroll for 2022. Motion carried all ayes.

Berdan motioned seconded by Saumer to accept the resignation of Isaac Johnson (November 10, 2022) and Karin Omae (November 21, 2022) from the Planning Commission. Motion carried all ayes.

Berdan motioned seconded by Christenson to appoint Stefon Boleen to the Rock Creek Planning Commission, first term is December 19, 2022 to July 31, 2024. Motion carried all ayes.

Ramberg motioned seconded by Berdan to approve the Resolution Establishing Precinct and Polling Place for the City of Rock Creek; Precinct 1 - Entire City limits of the City of Rock Creek, Polling Place – Rock Creek City Center, 7000 State Hwy 70, Junction of Highway 70 and County Road 61. Motion carried all ayes.

Ramberg motioned seconded by Saumer approval of the application LIB-22-002 for a Low Impact Business for Darin Schmidt to operate a Lawn Service/Landscaping business. Motion carried all ayes.

Christenson motioned by Ramberg to approve payment of check #'s 16456 – 16503 and e-transfers totaling \$68,130.86. Motion passed all in favor.

Christenson moved seconded by Saumer to adjourn at 7:57PM. Motion carried all ayes.
